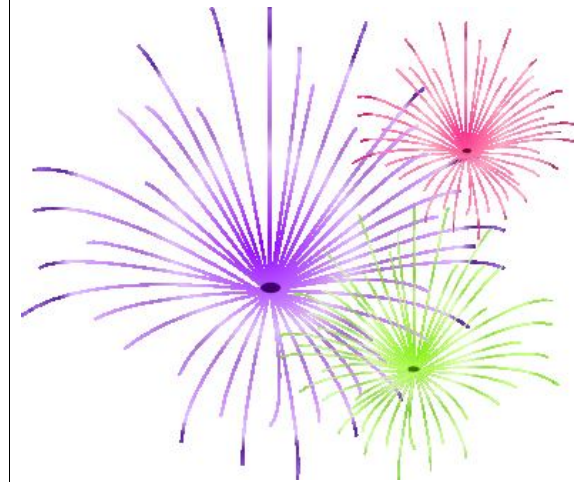

many states in the United States," he says.

Warren regrets that the clad strikes and the one-half pound \$300.00 strikes have hurt the hobby. "If more casinos would get back on board with a strike program with a .999 silver chase strike and a \$300.00 strike the hobby may survive. If only the silver strike program could go back to early 2001. It sure was a lot of fun playing the strike machines in those days," he says.

Warren's wife, Nora, frequently joins Warren at the tournaments and, when she is not playing a tournament machine, you'll find her playing on a Video Poker or Keno machine, or chatting with striker friends.

Warren's mother, La Verne, is 88 years young and a Las Vegas resident and avid Bingo player. "She just can't believe that all four of her children are retired," adds Warren.

Warren Schaefer: Silver Strike Pioneer

Fourteenth in a series of articles about club members who started collecting strikes in the early days and have contributed to the club's success.

"On a trip to Las Vegas in 1995 to see my mother, I won my first strike at Sam's Town. I can't recall which one. All I remember is that I went back to Chicago with about ten different \$10.00 silver strikes from Sam's Town and the Las Vegas Strip," says Warren Schaefer (SS185), who now resides in Henderson, Nevada with his

wife Nora.

The experience marked the start of his silver strike collection, first with \$10.00 issues, and then \$200.00 Nevada strikes.

"When Nora and I first moved from Chicago to Las Vegas in 1998 I really caught the silver strike bug. We would hit the Strip or downtown Vegas every weekend looking for silver strike machines. I would feed the strike machines one dollar at a time and hope I would win a strike before spending \$10.00 as I did not want to spend more than that for a strike. Three times I hit the three red 7's on my first pull and won five \$10.00 strikes for \$0.75 – two times at the Orleans and once at the Monte Carlo. In 2001 the Plaza came out with the first chase strike (Your Place in Town, Ltd. 100 – 2 for 1) in a yellow case and that started a string of silver strike tournaments, chase strikes in yellow, blue and then red cases and a lot more \$200.00 strikes," Warren says.

"I played for all newly released strikes in Las Vegas and traded them for strikes I needed in Reno, Laughlin and Las Vegas as well. I started selling my extras on eBay in February 2000 to help support my habit, and I'm still selling on eBay today," says Warren.

Warren was helped in those early days by Art Becker's first strike catalog and web site. "I would find out how many Nevada \$10.00 strikes were out there and inventory the strikes I already had and identify those that I needed. Two of my most exciting finds were the Trolley and Golden Gate Bridge strikes from the Golden Gate Casino," he says.

Warren joined the Silver Strikers Club in December 1999 and has attended all of the tournaments since the first one at the Flamingo/O'Sheas in 2001. He finished in third place at the Palms tournament in 2009. "I was forced into retirement almost nine years ago and, regrettably, I started selling off my collection at that time. I am still a member of the club because of the great friendships I've made through the club and my hobby. It sure is a great bunch of people," Warren says.

Now Warren helps other collectors build their strike collections, primarily by selling strikes on eBay that he plays for or sells for others who want to sell their collections. "You would be surprised how eBay has expanded interest in and collectors of silver strikes from people all over the world. "I have mailed strikes to collectors in Alaska, Hawaii, Canada, Spain, Hong Kong, England, Australia and many other countries plus

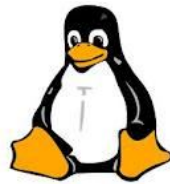

Club History

Some events of 2011:

January, 2011:

The new \$300 Silver Strike was approved by Nevada Gaming, a 6 ounce center with a copper ring which is gold plated. The first new \$300 Silver Strike was released the weekend of the Four Queens Silver Strike Slot Tournament.

Sam's Town had six new strikes available for play, four were from the original 12 cars which were approved last year. 70 Firebird, 71 AAR Cuda, 71 Formula 400, 71 Road-runner.

The membership roster as of January 2011 had 472 members.

The Four Queens Silver Strike Slot Tournament was held at the Four Queens Casino and Hotel.

February, 2011:

Sunshine Mint has all rights to the Silver Strike program. As the El Cortez starts celebrating their 70th anniversary in May they planned on having two silver strike machines with four new house strikes and a red cap by June 2011 for CC>CC convention. Sunshine has been talking with the Mirage and Circus Circus about the installation of Silver Strike machines.

It was announced that the Four Queens will have two red caps and two strikes to be available the Wednesday before St. Patrick's Day.

Las Vegas history:

In 1855, members of the Mormon Church choose Las Vegas as the site to build a fort halfway between Salt Lake City and Los Angeles, where they would travel to gather supplies. The remainder of the Mormon Fort can still be seen at the intersection of Las Vegas Boulevard and Washington Avenue. The fort was abandoned several years later. The site is now a state historic park.
